Julia E. Sullivan, FCIArb

Julia is an independent arbitrator with more than 35 years of experience in commercial transactions, complex business disputes, and international arbitration. She has been appointed in more than 170 arbitrations as sole arbitrator, chair, co-arbitrator, or emergency arbitrator, including international disputes involving parties and projects across North America, Latin America, Europe, Africa, and Asia.

Julia's arbitral practice spans a broad range of commercial disputes, with particular expertise in energy, construction, infrastructure, finance, partnerships, joint ventures, and aviation. Her experience includes disputes involving major infrastructure projects, renewable energy facilities, oil and gas operations, finance and financial instruments, securities, banking, construction, fiduciary duties, fraud, unfair competition, and U.S. and cross-border commercial transactions.

Prior to becoming a full-time arbitrator, Julia practiced law for nearly three decades with leading international law firms, including as Practice Manager for Energy Regulation, Markets & Enforcement and member of the Global Energy & Transactions Steering Committee at Akin Gump Strauss Hauer & Feld LLP, Economic Litigation Partner at Sidley Austin Brown & Wood LLP, and energy attorney with Skadden, Arps, Slate, Meagher & Flom LLP. Her legal practice focused on complex commercial litigation, energy regulation, project development, finance, and cross-border transactions.

Julia is a Fellow of the Chartered Institute of Arbitrators (CIArb) and previously served as Vice Chair (Membership) of the CIArb North America Branch. She is a member of ArbDB Chambers and serves on the rosters of various arbitral institutions. She has taught and lectured extensively on arbitration, project finance, and international commercial law, including appointments as Visiting Professor at universities in Poland, Georgia, and other jurisdictions. She is also an approved faculty member of the Chartered Institute of Arbitrators.

Julia's academic credentials include four advanced degrees: an LL.M. (Distinction) from the London School of Economics and Political Science, an LL.M. in International Business from Boston University, an LL.M. in Transnational Commercial Transactions from Lazarski University (Poland), and a J.D., summa cum laude, from American University Washington College of Law. Michael also served as a CIArb Trustee, CIArb Honorary Treasurer, as Chair of the Audit Committee, and was part of the CIArb Governance Review Working Party.

Based in Dubai, he is a Partner at HKA Global, a leading global consultancy, specialising in risk mitigation, dispute resolution, expert witness evidence and litigation support.

Michael's experience spans five continents and a wide range of institutional rules. He is a frequent speaker on expert witness evidence and the role of an arbitrator and has authored papers on these topics.

Ann is also one of ten arbitrators appointed by the United States Department of Trade to serve as a dispute settlement panelist pursuant to Chapter 31 of the United States-Mexico-Canada Agreement (USMCA).

Mauricio Gomm, C.Arb, FCI Arb

Mauricio is an independent arbitrator, mediator, and law professor with more than 35 years of legal experience, including over two decades dedicated to international dispute resolution. Dual-qualified in Brazil and New York and accredited as a mediator by CEDR, he has served as presiding arbitrator, sole arbitrator, co-arbitrator, emergency arbitrator, mediator, and expert witness in complex cross-border disputes conducted under the rules of leading arbitral institutions, including the ICC, ICDR/AAA, LCIA, CPR, SIAC, HKIAC, and UNCITRAL Arbitration Rules.

Mr. Gomm's practice encompasses a broad range of industries, including infrastructure and construction, energy, mining, corporate and M&A, international sales, and franchising and distribution disputes. He is a Chartered Arbitrator and Fellow of the Chartered Institute of Arbitrators and is recognized for his ability to bridge civil law and common law traditions in multilingual and multicultural proceedings. He conducts proceedings in English, Portuguese, and Spanish and is also able to serve in matters conducted in French.
