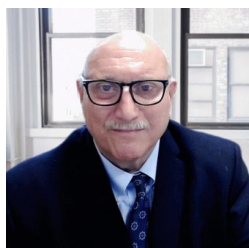
Lawrence S. Schaner (Chicago, IL)
