court to evaluate an arbitration award issued by an international panel with its seat in Washington D.C. and in Geneva, Switzerland, for confirmation or vacatur; and the scope of jurisdiction to the extent it does or does not empower an American court to preclude the party challenging the award from simultaneously pursuing "anti-suit" relief in European courts.

Parties confronted with arbitral award confirmation or vacatur should consult the decision and reasoning of the D.C. Circuit in the above appeal to attain vital guidance as to the scope and validity of the role of a United States Court to become involved in such a process. Such Courts may likely be "open for business" when it comes to determining their authority in award enforcement.

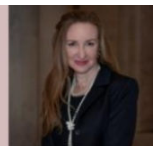
